Key Points for Schools

- No cost to the school.
- Recommend student teacher uses school device to record and upload.
- Mentors and School Coordinators do not need to login to the IRIS Connect platform themselves, but do need to be aware of it to support its use and to ensure you have the right processes in place.
- Each student has received information on how to login to IRIS Connect. They will need to share an uploaded video with another user (such as their Practice Tutor) before it can be seen by anyone else. Until a video is shared, only the student can
