Access and Participation Plan

What is an Access and Participation Plan?

Most higher education providers have Access and Participation Plans. These set out how they will improve equality of opportunity for underrepresented groups to access, succeed in and progress from higher education.

Fees we charge

Most OU students are considered part-time and study at a rate of 60 credits a year. For most students in England, it will cost £3,228.

Even if you choose to study at full-time equivalent intensity, you will still be considered a part-time student. That means your eligibility to claim existing state benefits and to fund your studies with a part-time tuition fee loan will usually be unaffected.

Key points

We are the largest provider of flexible part-time and distance learning in the UK, with students in England, Scotland, Wales and Northern Ireland. Our mission is to be 'Open to people, places, methods and ideas' and our vision is 'To reach more students with life-changing learning that meets their needs and enriches society'. Our students come from all backgrounds and all ages and there are no entry qualifications required for most of our courses.

We offer Access modules to help students find out more about their interests and develop their confidence and skills. At postgraduate level we have both taught and research programmes of study as well as degree-level apprenticeships, and higher technical qualifications. We also provide informal learning through our partnerships with the BBC and via our free OpenLearn platform.

Financial help available

We understand that finances can sometimes be a barrier to education. Our offer of financial support to qualifying students includes:

- Two scholarship schemes offering full fee waivers to disabled veterans and carers.
- A fee waiver for Access courses. This is for students with no previous experience of higher education whose income is less than £25,000 or who are in receipt of a qualifying benefit.
- Study-related costs schemes that provide support if a student's income is less than £25,000 or they are in receipt of a qualifying benefit.
- A one-off bursary of £250 for carers and care experienced students where their income is less than £25,000 or they are in receipt of a qualifying benefit.
- A one-off bursary of £1,000 for students who identify as being from a Black, Asian or minority ethnic background and their income is less than £25,000 or they are in receipt of a qualifying benefit.
- 50 scholarships for undergraduate study for Black students with no prior higher education qualifications and whose income is less than £25,000 or who are in receipt of a qualifying benefit.

What we are aiming to achieve

Our aim is to make access and success fairer for students from underrepresented and disadvantaged backgrounds. We want the University to work in a way that supports all students and enables success.

This Access and Participation Plan commits the University to address:

- Underrepresentation of Black and Asian undergraduates.
- Better degree outcomes for Black, Asian and minority ethnic students.
- Better progression after graduation for Black, Asian and minority ethnic students.
- Better degree outcomes for students with declared disabilities and students from the most deprived areas.
- Better progression to employment or further study after graduation for students with declared disabilities and students from the most deprived areas.

We have set ambitious targets for these priorities and track how well we are doing, and which activities are working well.
