#### **Presentation 1: University of Kent**

**Dave Thomas –** Senior Adviser in Equality, Diversity and Inclusion: Advance HE



Dave S.P. Thomas is a Postgraduate Research Student studying a PhD in Higher Education at the Centre for Studies in Higher Education (CSHE) at the University of Kent. Professor Kathleen M. Quinlan is Director of the Centre for the Study of Higher Education and Director of Research. Since gaining her PhD in 1996 from the School of Education, Stanford University, Professor Quinlan held academic or leadership positions in research universities in Australia (Australian National University), the US (Cornell University) and the UK (University of Oxford and University of Kent) and a consulting company (Concept Systems, Inc.).

Kathleen has published more than 45 peer reviewed articles, edited two books, and given 16 keynote lectures. Her research focuses on discipline-sensitivity in teaching and learning and students' holistic development. Kathleen is currently focusing on students' interest, as

well as their broader motivations for and experiences of studying in higher education.

## **Jo Hall –** Principal Lecturer and Inclusive Practice Lead: Learning and Teaching Hub



Dr Jo Hall is Principal Lecturer and Lead for Inclusive Practice in the Learning and Teaching Hub at the University of Brighton. In this role, Jo manages the Inclusive Practice Partnerships Scheme, a cross-University project to diversify and decolonise the curriculum in partnership with students, and the Professional Recognition and Development Scheme, the University's accredited, experiential route to Fellowships of Advance HE. Her research focuses on race equity, focusing particularly on the affective and performative nature of value structures within Higher Education curricula.
